Over the past year we have been working closely with NSWA on the Riparian Intactness project which was funded through CAP program. The project is using Satellite imagery to inspect 7000 km throughout the watershed and develop an online web portal to share the information with a boarder audience. Thirsk, a Canadian astronaut. We are working with Samson Cree Nation on water protection. We have 2 staff for an 8-month contract, doing research on climate change, climate adaptation and recommendation for building our reliance. Continue working with youth programs and engagement events. Youth programs a big part of our work, excited to take kids outside and build their appreciation for our watersheds. X-steam science program grade 7-12 out to do water quality monitoring. We continue with the CFW competition. Some fantastic projects from the CRW Competition have been implemented. Due to COVID-19 we have developed a virtual program for the Waste in the Watershed Tour. We are looking for sponsors to help us expand the Waste in the Watershed Tour outside of Camrose. We continue to offer the Discover Your Wetlands programs through out the watershed. We held our first ever Magpie Nature Camp, which was a week long day camp 8-12 year olds. Funds from Cargill helped support this camp which took place at the Fish and Game site. We have received funding for a Future Farmers for fresh water project where we will be working with local 4H clubs. We held out Annual Watershed Festival at Big Knife provincial park. We were once again able to hold a successful Saskatoon Pie at the Camrose Downtown Farmers market. To appreciate the Christmas season and all that our members and volunteers do for us we held the Winter Tales event at the BRWA office in December. Funding was received to have a Finding Common Ground 2 bus tour. We explored different energy opportunities to hear from people and develop more informed knowledge. Energy ambassadors then presented to their community. Paddle the Battle has 17 guides for different locations where paddling is accessible. We continue to celebrate stewardship though the OTIS award which is awarded on a yearly basis. Riparian restoration program funding through WRRP. Several projects completed throughout the years. The Buffalo Tail program working with 9 land owners and cows and fish to complete riparian health assessment on the land. Riparian fencing, livestock shelters, watering systems.
